## SECTION 5: Fire-fighting measures

### Extinguishing media:

Do not reuse empty container without commercial cleaning or reconditioning. Empty container contains residual product which may exhibit hazards of product. Plasticizer products will soften plastic materials and as a result they should not be transported in piping systems constructed from these materials.
